#### PARISH COUNCIL NOTES

The Parish Council has a new Chairman, Dr.Brian Smith. The Vice-Chairman continues to be Mrs.Brenda Crimaldi.

A diversion will be caused by the bridge works on the Bll15 at the culvert near Mill Mill Cottages. The Bll15 will be closed from Monday, 7th June to Monday, 12th July inclusive, and a diversion through Buxhall will operate.

Suffolk County Council's policy on grass-cutting and verge maintenance will be the same as in 1981: i.e. cutting for visibility at bends, road junctions and signs, beginning this month.

Following a complaint, a ruling as to the rights of way at the Valley Lane/Jacks Lane junction has been requested.

At the last Parish Meeting the subject of parking facilities for the Eungalows, High Road was again raised. The District Council has now stated that it is hoping to proceed with the construction of an access drive and hardstandings. However, land has yet to be obtained for the visibility splay, vehicle crossing and access road but the possibilities are being investigated.

After consulting St.George's School on the proposed Saturday bus service, it was decided to take no further action on the matter.

A public meeting to discuss entry into the Inter Village Sports Competition was held on 7th May and attended by 10 young people. It transpired that there were insufficient participants to enter a proper team.

A grant of fl,800 has been paid to the Pettiward Hall Committee as a contribution to the recent improvement work. In addition, the Council agreed to grant a sum of  $\pounds527.18$  to the Hall Committee annually for five years commencing November, 1982. This will allow the Committee to pay off the loan of fl,750 which was raised to part fund the improvement work.

Further letters of complaint about the disturbance caused by clay pigeon shooting at St.Ceorge's School on Saturday afternoons were received. In addition, a number of similar complaints had been made to Councillors. Concern has also been expressed about the possible danger of shooting over a public footpath. It was reported that a School representative had made suggestions to residents in the vicinity of ways in which the situation might be improved. Council was told that the Suffolk County Council had now taken up both points of noise and public footpath issues and were now in the process of investigation and deciding upon a ruling which was expected soon. In view of this, the Council decided it would await the outcome before taking any further action.

Councillors were surprised and astonished at the outcome of the Inquiry into the Appeal against enforcement notices served on land in Combs Lane used as a gypsy caravan site. The decision allowed an unrestricted number of caravans on the site but put a ban on trading. This seemed totally against established planning policy for the area. Concern has been increased by the decision in a more recent Appeal concerning a gypsy site at Thrandeston, also in Mid Suffolk, where the Inspector found for the District Council because of the state of the ground being too wet for caravans. It was agreed the MP for Eye, John Cummer, be invited to discuss the issues involved in the situation, possibly at a meeting of local residents.
