Points from the last meeting (15th July)

Clearance of the City Lane footpath by the Conservation Team was being carried out.

The owner of the unauthorised tip near Finborough Bridge had appealed against the Enforcement Notices requiring the end to tipping and restoration of the site. The Parish Council was in agreement with the County Council attempts to stop the process of conversion by tipping. It was also noted that the owner (in his appeal) wished to reclaim by filling and levelling to a grass field for ivestock. However this did not accord with a recent report in the Bury Free Press that the intention was to develope the land for use as a caravan site. Furthmore, since early June several vehicles had been stored on the site behind an earth wall built well away from the road.

Council was in agreement with the Governors of the Primary School that the damaged chain link fence on the playing field be removed but that the concrete supporting posts would remain.

The outbreak of vandalism in the village had included the play equipment next to the Chestnuts estate. The swing seats had been smashed within a few days of being repaired. Also there had been damage to the brickwork on the play castle. The local Police, following an approach by the Council, have decided to keep a close watch on the village over the next few weeks and residents are requested to inform the Police (or Councillors) if they witness any vandalism or have any information as to the culprits.

The District Council considered that the 'mobile home' on the gipsy caravan site fell within the statutory definition of a caravan. The Parish Council was not of this opinion and has written to the Chief Planning Officer setting out its views and pointing out that childrens swings had been erected on the adjoining field.

An Emergency Adviser for the parish was still required.

The Parish Council was opposed to the planning application which south permission for the erection of house and garage for the headmaster at St.Ceorge's School because the proposed site next to the former Electricity Board training school was outside the area designated for further building. The Council representatives who attended a site meeting with members of the District Council found that their comments were almost ignored and in fact had to walk out of the meeting in order to bring their views to the notice of those in charge.
